INTRODUCTION

At the International Schools Partnership (ISP), learning is at the heart of everything we do. As a global group of schools our students benefit from being part of a wider international community, providing a wealth of learning and cultural opportunities. Our **International Learning Opportunities** (ILOS) give students the chance to connect with other ISP students from around the world.

Model United Nations (MUN) conferences enable students to come together from around the world to experience an educational simulation of a real UN conference. They empower students to put themselves 'in the shoes of global leaders', to better understand international affairs and global politics from unfamiliar perspectives, to build empathy and grow their skills in diplomacy, debating, team work and leadership.

In 2018, we held the first **ISP Model United Nations**, 'Together we can make a difference', hosted by **Laude The Lady Elizabeth School** in Spain. A second ISP MUN, 'Solving Issues – Building the Future', took place at **St. Jude School** in Costa Rica in 2019. The third annual ISP MUN was planned to happen in March 2020 hosted by **Tenby Schools Setia Eco Park** in Malaysia, but unfortunately it was postponed due to the COVID-19 pandemic.

ISP Virtual MUN 2021

From **21st – 23rd May 2021** we will host the first **ISP Virtual MUN**. While nothing will replace the special experience of being together in the same place, we are partnering with the fantastic team at **IMUNA** to provide an online experience that recreates the unique environment of an MUN as authentically as possible.

We are fortunate to have schools in many countries around the world which makes the ISP Virtual Model United Nations experience a truly international one. The conference is a valuable international and cultural experience for our students to take with them into their future. Beyond the debates it is a unique learning opportunity for our students to meet people from different countries and cultures make connections from around the world and foster long term friendships.

Through taking part in the ISP Virtual MUN, students will:

- Practise and develop their skills in organisation, leadership and responsibility.
- Develop critical thinking skills about complex global issues.
- Build skills in research, public speaking, debating, teamwork, negotiation, problem-solving, and conflict resolution within a multicultural framework.
- Develop greater knowledge and understanding of language, geography, history, international relations & diplomacy, environmental issues, traditions, lifestyle and culture.
- Participate in a unique international and cultural learning experience that enables them to interact with other ISP students across the world.
- Explore new ways of thinking and learn from each other as they work to achieve consensus across diverse points of view.

After registration students will receive a delegate pack with information about their country assignment and the topics they will debate.

In the run-up to the conference MUN delegates will need to:

- Attend weekly online training sessions (or watch later)
- Research their country and committee topics
- Complete the activities in the delegate guide
- Practice debating

Authorisation for the Recording and Use of Image Rights
